

2. Good Practices of effective technical assistance and examples of Positive impact related to the Declaration:

- i) Revealing the Truth and Fact that "Black"(People of African Descent are also erroneously called "Black") People have no standing at law. The WGEPAD should inform "Black" People / People of African Descent that they must change their commercial status to White(if they are from east of the Atlantic Ocean) or White and American Indian(If they are born West of the Atlantic Ocean) by

doing the US OMB SF-181 Form(and for those that are disabled the SF-256 form(https://www.opm.gov/forms/pdf_fill/sf256.pdf) .

ii) Confirming Whether “Black” People/People of African Descent are human? This should be answered by the UN Secretary General, The OHCHR, The United Nations Security Council and the UN General Assembly once and for all; Further The OHCHR should admit or deny the following:

a) Whether “Black” People / People of African Descent have standing at law- World Wide.

b) Whether “Black” People / People of African Descent are human and whether they are entitled to Human Rights and Protections domestically and Internationally.
