In reference to your letter dated 12 July 2017 soliciting ADB's contribution to this important work. We are pleased to share with you the tools that ADB uses to guide poverty, social, and gender impact analyses at the country, program and project levels.

Handbook on Poverty and Social Analysis (2012) - This is resource material intended for ADB staff, government officers, consultants, and other stakeholders to help them effectively assess and ultimately address the poverty and social dimensions of ADB operations. The handbook provides guidance on poverty and social analysis across ADB's operational cycle and business processes, and is used as reference material for staff training on Poverty and Social Analysis. Handbook on Core Labor Standards (2006) - This is a joint publication by ADB and ILO, and is intended to provide practical guidance to policymakers, ADB staff, consultants, and members of implementing/executing agencies on how ADB operations can comply with core labor standards, or how core labor standards can be integrated into operations.

As specified in the Poverty and Social Analysis handbook, an initial poverty and social analysis (IPSA) is a mandatory requirement for ADB project concept papers and project preparatory technical assistance reports as well as for some grant assistance reports; the summary poverty reduction and social strategy (SPRSS) is mandatory for all Report and Recommendation of the President document (a decision document for ADB project and programs). The latest versions of the templates are attached. ADB's Public Communications Policy (<a href="https://www.adb.org/documents/pcp-2011">https://www.adb.org/documents/pcp-2011</a>) requires that IPSAs are posted on ADB's website (para 56, page 17).

Gender Mainstreaming Guidelines (2012) - All ADB projects are required to include a gender analysis during project preparation to inform gender-inclusive project designs and targets. Projects are categorized into one of the four gender categories, of which the top two categories ("gender equity theme" and "effective gender mainstreaming") are considered as "gender mainstreamed" and require gender action plans.
